The Overcoming Hurdles in Ohio Youth Advisory Board is a statewide organization of young people, ages 14-24, who have experienced foster care.

The OHIO YAB exists to be the knowledgeable statewide voice that influences policies and practices that impact youth who have or will experience out of home care.



Educational stability of children in foster care is a joint responsibility between schools and child welfare agencies

Districts must designate a foster care point of contact to work with the local child protection agency.

Ohio's ESSA Plan requires:

Every school district to identify a single point of contact for students in foster care:

- To coordinate with child welfare
- To develop a process for making best interest determinations
- To facilitate transfer of records and immediate enrollment
- To support enrollment and regular attendance in school
- To coordinate transportation
- To share data with child welfare agencies
- To provide professional development training for school staff

Feedback from Ohio Foster Youth

Why haven't I heard of this before?

There's nobody there for me at school.

I need somebody who understands me as a foster youth specifically.

I don't have the parents I was born to, so I need more support.

District Foster Care Liaisons

These positions exist on paper but not in practice.

Lack of outreach to students.

Every school district differs in their approach.

Role is often assigned to principal or staff member wearing many other hats.

For Foster Care Liaisons throughout the state to be designated not only by name, but also by training, support and by their daily actions to support our vulnerable population.

Structural Recommendations

Oversight by the Governor's Office and/or Ohio Department of Education
to ensure every district has a Foster Care Liaison. This would need to be done
by a team of people to be effective and lasting.


- Accountability measures: Tracking, signed forms so there is no question that student-liaison connections are actually happening.
- **ESSA to know who students are and vice-versa:** School to maintain records of which students are in/from foster care --- along with policies and procedures, similar to safeguards regarding students with special needs.

Identification of District Foster Care Liaison

• Not a Principal: Conflict of interest; perception of being punished.

 Not wearing multiple other hats, because this can lead to burnout, secondary traumatic stress, becoming overwhelmed, things pile up and they can't be their best for the student.

Youth Recommended Qualifications of District Foster Care Liaisons



For Foster Care Liaisons throughout the state to receive mandatory training, in order to be well-informed about the rights and resources of foster youth.

Training for District Foster Care Liaisons

Know what ESSA is, and what the role requires

Understand the foster care experience, and how it can impact educational progress.

Trauma-informed



Share the Foster Youth Bill of Rights with students

Let students know about the Youth Ombudsman Office

Knowledgeable about resources (ETV, FAFSA, etc.)

For Foster Care Liaisons throughout the state to consistently demonstrate initiative to proactively reach out to foster youth in grades K-12.

Impact of Active District Foster Care Liaisons


Importance of building trust and providing guidance.
