Next Steps Here in Ohio

- **As Ohio implements A Home for Every Child, and seeks to recruit 7K foster families,** how can we help, including when it comes to adequate safety vetting, training, retaining and how to support foster families in the midst of caseworker turnovers and shortages? ***An influx of this magnitude requires adequate infrastructure.***
- What are Ohio's plans to act on ACF guidance to stop paying adoptive families after failed adoptions?
- Does Ohio currently assign children and teens with a unique identification number, that can help track if they are adopted and end up back in foster care?

Future Discussions:

- **Pros and cons of assigning children and adoptive families the same caseworker:**

Model	Advantages	Potential Drawbacks
Same Caseworker (Single Worker)	• Seamless Communication: Eliminates the risk of critical information falling through the cracks between separate departments. • Deeper Context: The worker intimately understands both the child's trauma/behavioral needs and the family's direct capabilities. • Efficiency: Speeds up the administrative matching process.	• Objectivity Concerns: The worker may develop a subconscious bias or conflict of interest during the matching phase. • Role Confusion: It can be difficult for one worker to advocate equally for the child's best interests while simultaneously managing the adoptive parents' expectations.
Different Caseworkers (Co-Managed)	• Checks and Balances: Ensures two distinct professionals evaluate the match, providing a built-in safety net against individual bias. • Dedicated Advocacy: The child has a dedicated advocate focused strictly on their permanency, while the family has a guide focused on their licensing.	• Communication Silos: Information sharing can slow down, sometimes lengthening the timeline to finalization. • Conflicting Perspectives: Disagreements between the child's worker and the family's worker can delay the placement process.
